Dear Parents and Guardians,

What a year! There are almost no words left to adequately describe the ups and downs of the past 18 months. We've lived through a tremendously fractured time characterised by constantly changing circumstances – often at little notice – and more compromises to our day-to-day experience than any of us feels comfortable accepting. And yet, despite this, our students have continued to surprise and delight with their remarkable achievements and, in general, their positive and optimistic attitude has carried us through. If this period has taught us anything, it has taught us that we can never take the presence of live music for granted and it has underlined just how vital and important it is to our overall wellbeing. # Relationship and Sex Education

All schools are required to review and update their policies and teaching on RSE and there are now new statutory requirements in place (although their implementation has been allowed to be delayed where schools have experienced significant Covid-19 disruption). We will be publishing a new draft policy towards the beginning of the new academic year and will circulate this to parents at that time along with an opportunity for you to comment on the content. We are currently taking advice and guidance from various external advisors on best practice in this area and as we formulate the new policy, we would welcome any initial thoughts you may have about approaches to this area of the curriculum. This is not the time to submit requests for withdrawal from those noncompulsory elements - this will come later - but rather, if you have thoughts in general terms about the approach the School might take, this is

the time to share them. We will consider these when building the new policy and will circulate this prior to the beginning of the new year and invite any specific comments on the draft policy at that time.
